How to Pay

You can now pay your membership via the front page of the Society's website, send a cheque or set up a Direct Debit (see overleaf).

Currency

Our subscriptions are shown in UK pounds sterling (£). You may pay by MasterCard (Debit/Maestro), Visa (Debit/Electron). We recommend you use a credit card if you live outside the UK: your card or account will be debited the equivalent amount in your own currency.

Direct Debit

For those with a British bank account, the best way to pay for your membership in future years is via direct debit using a variable amount direct debit mandate. This is strongly recommended, since it means that your annual subscription is collected every January, without any further effort from yourself. If the mandate is set up part way through the year, please allow 3-6 weeks before collection is taken for the current year as collections are made in the first week of each month.

Direct Debit applications must be sent in on the original form. Photocopies or scans are not acceptable.

Please Note: Members will incur a £10 administration fee for any unpaid Direct Debits.
