- 🐾 Please ensure you have completed this form fully and checked all required fields have been completed, including the markings, description, and that the vet has implanted a microchip, recorded the number and its location in the body.
- 🐾 The age of all equines is calculated from the 1st of January.
- 🐾 Mandatory DNA profiling of mares is required for all mares producing their first pure-bred foal.
- 🐾 Mandatory DNA parentage testing is required in the following cases:
 1. To register a pure or part-bred foal (excluding those registered as geldings) bred by A. I. when conceived by the use of Frozen Semen only.
 2. For any pure-bred colt/filly late entry application received after the 1st of January of the yearling year.
- 🐾 DNA kits can be purchased by indicating below. Please enclose the **name and address of your veterinary practice** so the DNA hair sampling kits can be sent out directly to them.
- 🐾 The Society recommends all application forms and passports are sent using recorded or tracked postage. We strongly advise all customers to purchase the same for the return of passports. Please either enclose a pre-paid postage self-addressed envelope or alternatively, you can select the return postage options below.
- 🐾 Turnaround time for all registrations is 15 working days, providing there are no errors preventing the processing of the form.
